Mr. Satoru Yamadera, Director, Head of International Standardization Group, Institute for Monetary and Economic Studies, Bank of Japan: He leads standardization in Japan including ISO 20022 and mobile financial services as a secretariat of ISO/TC68 committee of Japan. He also initiated the project to set up ASEAN+3 Bond Market Forum (ABMF) when he attached to Asian Development Bank. Currently he is the Chair of LEI ROC Committee on Evaluation and Standard (CES).
